
- ...represents the highly innovative, R&D-driven crop protection industry in Europe

  - ensuring safe and affordable **food**; safeguarding **water**; enhancing **biodiversity**; protecting the **health** of farmers and the public





Art 22 (substance): low risk substances (15 years authorisation)


Art 47(products): low-risk products

### Organic and bio control offer: a reality for our members (France)



- Insecticides and fungicides authorized for organic farming in France supplied by UIPP (French CPA) members
  - 135/376 (40 %)
  - 16/21 UIPP members (\*) are offering solutions for organic farming (75%)
- At end of 2012, 39 substances and 79 products available in France for the "NODU vert" (indicator for green products)
  - 37 products (47%) supplied by UIPP members

(\*) :11 ECPA members/20 members are IBMA members



#### **Biocontrol part of the strategic approach of our members**

- EU R&D focus for Crop Protection is decreasing (30% in 1980s and less than 8% today!)
- Biocontrol solutions in general more complicated to implement (labs/field)
- A "Without promising more than we can deliver" approach!
